UCI International Center Dependent Visa Document Request Form

Legal dependents (spouse and children) of international students or scholars may enter the U.S. as an F-2 or J-2 visa holder. An F-2/J-2 may only stay in the U.S. as long as the F-1/J-1 is in status and participating in a program at University of California, Irvine.

Required Documentation to Request a Visa Document for a Dependent:

- 1. Passport Biographical Information Page(s) for Dependent(s)
- 2. Financial documentation verifying funding for each dependent in U.S. Dollars and in English

Financial documents must be less than 3 months old from date of request. Funding must demonstrate at least \$5,400 *per* dependent (approximate \$600 a month/per 9 month academic term) in addition to funding necessary to support Student/Scholar. Acceptable forms of financial documentation:

- Bank statement/letter verifying funds in F-1/J-1 visa holder's name
- Bank statement from sponsor, along with an original letter of support
- Award letter from government foundation, agency, or corporate fellowship providing funding for dependents (if applicable)
